# CHECKLIST BEFORE YOUR SHOOT

Before embarking on your shoot, read the rules and regulations to make sure you are eligible to enter your category.

For each entry, you must include:

## 1. FOUR FINAL IMAGES

- Each photograph must be 10" x 8" (i.e. portrait dimensions). The total size should include any borders. Photographs should be supplied on photographic paper, or other thick paper to prevent damage when in transit. We would suggest a paper weight of 300gsm.
- Each image must have your name, salon name, and category on the back. Do not write directly on the back of your image; use a label and write the information on before you attach.
- You must also label the back of your photograph to declare where wigs, hairpieces and/or strands have been used. This is compulsory.
- Digital versions of your images are required with your first round entry. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry. ([bha.evessiocloud.com](http://bha.evessiocloud.com))
- A crib sheet, with your pictures in the order which you would like them to be displayed at judging. If this is not provided, the organisers will display them at their discretion.

## 2. BEFORE IMAGES

- You must include a 'before' picture of each model, if applicable for your category. This should be taken on the day of the shoot, prior to any hair work, make-up or styling. Failure to provide these may result in disqualification.
- These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

## 3. PRE-PRODUCTION IMAGES

- You must include an 'after' picture of each model, before any post-production or retouching. Failure to provide these may result in disqualification and the organisers and judges reserve the right to question any photographs which appear to have been edited.
- These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).



## 4. VIDEOS

- You must take two, 360 degree videos of each model: one 'before' prior to any hair work, make-up or styling, and one 'after', before any post-production or retouching. This can be shot on your phone.
- Please upload these videos to Evessio (our online platform) as you complete your entry. ([bha.evessiocloud.com](http://bha.evessiocloud.com)).

## 5. QUESTIONNAIRE

- For entries in the Artistic Team of the Year and Schwarzkopf Professional British Colour Technician of the Year, please ensure you download the entry form from Evessio (our online platform), and complete and return the physical copy in the post with your entry. ([bha.evessiocloud.com](http://bha.evessiocloud.com)).

## 6. ENTRY FORM

- Download the entry form from Evessio (our online platform) [bha.evessiocloud.com](http://bha.evessiocloud.com), complete, sign and return in the post with your photographs. You will need an entry form for each entry you send. This is to ensure we can allocate the images to your online entry.
- For Newcomer of the Year, please ensure your employer has signed the declaration and enclose a copy of your passport or driving licence.

## 7. PHOTOGRAPHERS' DECLARATION

- Ensure your photographer has completed and signed the declaration section.
- The deadline for entries is 5pm, Friday 30th June 2023 and late entries will not be accepted.

# JUDGING AND AWARDS

## ► WHAT HAPPENS AT THE JUDGING?

- All photographs are judged anonymously and independently.
- Judges are unable to see the name, or salon name, of any entry.
- All entries are displayed by category, on boards. Before and pre-production shots are also made available to judges.
- Judges are not permitted to judge any category which includes the work of someone in their employment. Further, if a judge has advised or otherwise worked with an entrant in any category, they are not permitted to judge that category.
- Once judging is complete, the marking form is handed to an independent, on-site auditor. Forms cannot be changed or edited once handed to an auditor.
- Judges are not allowed to discuss entries before, during, or after judging, and must sign a non-disclosure agreement to confirm this.
- The entire judging process is supervised and strictly controlled by both the organisers and independent auditors.
- Six finalists will be selected in each category based on the marks received, with the exception of British Hairdresser of the Year and Session Hairdresser of the Year.
- The judges' decision is final. No correspondence will be entered into.

## ► WHAT HAPPENS AFTER THE FIRST ROUND OF JUDGING?

- All entrants will be informed by email, whether or not they have finalised.
- Successful finalists will then be asked to submit a further four photographs, making a total collection of eight images. For Trend Image of the Year, no further images are required and for Newcomer, a further two images are required.
- The closing date for the second round is 5pm, Friday, 25th August 2023.
- The work of the finalists in each category, plus nominees for British Hairdresser of the Year and Session Hairdresser of the Year, will be displayed in the British Hairdressing Awards Gallery at Salon International 2023, which takes place from 14th–16th October at ExCeL London.
- Details of successful entrants will also be published in Hairdressers Journal International and on [hji.co.uk](http://hji.co.uk). Award winners will be announced at the Awards ceremony on Monday, 27th November at JW Marriott Grosvenor House, Park Lane, London W1.
- Information regarding successful candidates or winners will not be given out over the phone.
- Anyone under the age of 18 years by Monday, 27th November will not be permitted to attend the British Hairdressing Awards.



# RULES AND REGULATIONS

## ► WHO CAN ENTER?

- Any qualified hairdresser who works within the regions outlined on pages 7 and 8 can enter the regional categories.
- Entrants must work in a commercial environment, and have done so for a minimum of three years (excluding training).
- Entrants must have a regular client column within the region entered. This means working regularly with clients, in a salon, for a minimum of one day per week. This may be checked.
- Work submitted may be published work with the exception of British Hairdresser of the Year where only unseen collections can be submitted.
- Images entered must have been photographed between 2nd July 2022 and 30th June 2023.
- An individual can only enter from one salon, in one region, in any one year.
- No employee of Hairdressers Journal International or Schwarzkopf Professional, or their families, will be allowed to enter or judge the British Hairdressing Awards.
- Winners recognised in the Hall of Fame can re-enter their chosen category after a two-year rest period.

## ► HOW TO ENTER

- Submit four photographs with hair created by you, and shot between 2nd July 2022 and 30th June 2023.
- Please include all of the following:

### 1. FOUR FINAL IMAGES

- to be provided in print and online on Evessio (our online platform) [bha.evessiocloud.com](http://bha.evessiocloud.com).
- Each photograph must be 10" x 8" (i.e. portrait dimensions). The total size should include any borders. Photographs should be supplied on photographic paper, or other thick paper to prevent damage when in transit. We would suggest a paper weight of 300gsm.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

### 2. BEFORE IMAGES

- You must include a 'before' picture of each model. This should be taken on the day of the shoot, prior to any hair work, make-up or styling. Failure to provide these may result in disqualification. These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

### 3. PRE-PRODUCTION

- You must include an 'after' picture of each model, before any post-production or retouching. Failure to provide these may result in disqualification and the organisers and judges reserve the right to question any photographs which appear to have been edited. These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

### 4. VIDEOS

- You must take two, 360 degree videos of each model: one 'before' prior to any hair work, make-up or styling, and one 'after', before any post-production or retouching. This can be shot on your phone.
- Please upload these videos to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

**Please note:** should you go through to the second round, you will need to supply a further four images to make a collection of eight. These will also need to include before and pre-production shots, as well as videos, as outlined above.



# RULES AND REGULATIONS

## ► WHAT TO KNOW BEFORE YOU SHOOT

- Photographs may be black and white or colour and the hair should be aspirational, wearable and reflect current trends.
- Professional photographers, make-up artists and stylists may be used, and must be credited on your online entry form.
- Images can be full length, but the hair should always be the focus.
- No more than two faces may appear in any one photograph.
- Hair work must be presented on real models (i.e not training/doll heads or mannequins).
- Four wigs can be used in total, and extensions, hair pieces, and strands can be used in two further images. You must declare which pictures contain the above by labelling the back of the pictures with the words 'wig' or 'extension/hair-piece/strand'. Failure to do so will result in disqualification.
- Please check the specific rules regarding wigs in both Men's and Schwarzkopf Professional British Colour Technician of the Year categories.
- Please bear in mind that should you get through to the second round, you will be asked to supply a further four photographs. Please ensure that you have only used a maximum of four wigs in total and extensions, hairpieces and/or strands in two additional pictures in the overall collection of eight photographs.
- No more than four pictures can be used in two different categories, with the exceptions outlined below:
  - If entering Newcomer or Avant Garde, your pictures cannot be entered into any other category.
  - If entering Schwarzkopf Professional British Colour Technician of the Year, the same eight images can be entered into a region.
  - Images entered into Trend Image can be entered into any other category.

# SPECIALIST CATEGORIES: INDIVIDUAL CATEGORY RULES AND REGULATIONS

As well as the general rules and regulations outlined on pages 4 and 5, it is essential you read below the rules and regulations specific to the category you are entering.

## AFRO HAIRDRESSER OF THE YEAR

- Work must be created on Afro hair



## ARTISTIC TEAM OF THE YEAR

- A team requires a minimum of three people.
- Each member of the team must be a qualified hairdresser.
- All members of the team must have worked together for the same salon, salon group or recognised hairdressing body during the last 12 months (between 2nd July 2022 and 30th June 2023.)
- As well as your photographic images, the team must complete a standard questionnaire. This can be downloaded via Evesio and will need to be complete and sent in print format with your images. Please note that the name of your salon, team, or individual team members must not appear anywhere on this questionnaire so that it can be judged anonymously.

## AVANT GARDE HAIRDRESSER OF THE YEAR

- **Images entered in this category cannot be entered in any other category.**
- You do not need to supply 'before' shots in this category, however you must supply pre-production shots.
- The use of wigs, extensions, hairpieces or strands is permitted in all photographs.
- Images should demonstrate progressive styling with an emphasis on innovation and technique.



# SPECIALIST CATEGORIES: INDIVIDUAL CATEGORY RULES AND REGULATIONS

## MEN'S HAIRDRESSER OF THE YEAR

- Work must be carried out on models who identify as male.
- Hair pieces/strands can be used in two images in total – wigs are not allowed. For clarity, if you become a finalist you can only use hair pieces/strands in two images in the entire collection.



## NEWCOMER OF THE YEAR

- Entrants must be aged 27 years of age or under by Friday, 30th June 2023.
- Entrants must be based in a salon in the UK, and have been qualified for a minimum of two years and a maximum of five years.
- A photocopy of your passport will be required to prove your date of birth; details of your client column will also be checked and your salon owner/manager is required to sign and validate your eligibility for entry.
- Entrants to this category may not enter any other category.
- Previous winners cannot re-enter this category.
- Images submitted in the Newcomer of the Year category cannot be entered into any other category.
- You will be required to send four images for the first round judging and finalists will be required to send a further two images, making a collection of six.

## TREND IMAGE OF THE YEAR

- This category is open to freelance, self-employed and salon-based hairdressers who are either training or qualified.
- You need to supply a single 10" x 8" image showing commercial, wearable, hair that reflects current trends.
- This image cannot be entered into any other category.
- Only one entry is permitted per stylist.
- Should you go through to the second round, you will not be required to enter any further images.
- Entrants can use wigs and/or hairpieces, but the image has to show consumer-friendly hair and should not be avant garde.



# SESSION HAIRDRESSER OF THE YEAR

PLEASE NOTE, THIS CATEGORY IS BY NOMINATION ONLY

The closing date for Session Hairdresser Of The Year is 5pm, Friday 25th August 2023

- If nominated, you will be informed by the end of May 2023.
- You will be asked to submit a portfolio of eight 10" x 8" photographs.
- These images can be published.

Please include all of the following:

## 1. EIGHT IMAGES

- Each photograph must be 10" x 8" (i.e. portrait dimensions). The total size should include any borders. Photographs should be supplied on photographic paper, or other thick paper to prevent damage when in transit. We would suggest a paper weight of 300gsm.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](https://bha.evessiocloud.com).



# SPECIALIST CATEGORIES: INDIVIDUAL CATEGORY RULES AND REGULATIONS

## SCHWARZKOPF PROFESSIONAL BRITISH COLOUR TECHNICIAN OF THE YEAR

- All work submitted in this category must be created using Schwarzkopf Professional colour products only. Schwarzkopf Professional are offering entrants six shades of Chroma ID colour, free of charge, for use in their colour entry\*. To request the Chroma ID products, please email [telesales@henkel.com](mailto:telesales@henkel.com) or call LWPR on 01858 419668. \*shade guide also available upon request.
- Two wigs maximum can be used in the collection, but no hair pieces or strands. For clarity, if you become a finalist you can only use two wigs in the entire collection.
- Please ensure that nothing appears in the photographs that could be used to identify the entrant, e.g. branded gowns.

**Please include all of the following:**

### 1. FOUR FINAL IMAGES

- Each photograph must be 10" x 8" (i.e. portrait dimensions). The total size should include any borders. Photographs should be supplied on photographic paper, or other thick paper to prevent damage when in transit. We would suggest a paper weight of 300gsm.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

### 2. BEFORE IMAGES

- 10" x 8" (portrait) full colour, high resolution photographs, of the same model's hair before colouring. These images are required in print form and digital.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

### 3. PRE-PRODUCTION

- You must include an 'after' picture of each model, before any post-production or retouching. Failure to provide these may result in disqualification and the organisers and judges reserve the right to question any photographs which appear to have been edited. Each photograph should be no larger than 10" x 8". These images are required in print form and digital.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).



### 4. VIDEOS

- You must take two, 360 degree videos of each model: one 'before' prior to any hair work, make-up or styling, and one 'after', before any post-production or retouching. This can be shot on your phone.

**Please upload these videos to Evessio (our online platform) as you complete your entry**

### 5. QUESTIONNAIRE

- As well as your photographic images, you must complete a standard questionnaire. This can be downloaded from Evessio and needs to be completed and included with your photographs when you send them in [bha.evessiocloud.com](http://bha.evessiocloud.com).
- The questionnaire covers the process for each look, outlining information including texture, porosity, previous colour applications and other relevant information. You may include additional photographs to demonstrate the colour process, but please ensure that nothing appears in the photographs or technical portfolio that could be used to identify the entrant i.e. branded gowns.

Please note: should you go through to the second round, you will need to supply a further four images to make a collection of eight. These will also need to include before and pre-production shots, as well as videos, as outlined above.

- The before and after photographs, together with your questionnaire, should be supplied in **a plain, black A4 folder** in the order in which they are to be displayed. This black folder should be supplied by the entrant and have no identifiable writing on it.
- As the photographs will be removed from the folders for judging, please ensure that you label each 'before' photograph and 'after' photograph and corresponding questionnaire with a number, so that they can be clearly identified during the judging.
- Please do not glue your photographs into the folder as they will need to be removed for judging.

# BRITISH HAIRDRESSER OF THE YEAR

PLEASE NOTE, THIS CATEGORY IS BY NOMINATION ONLY

**The closing date for British Hairdresser of the Year is 5pm, Friday 25th August 2023**

- If nominated, you will be informed by the end of May 2023.
- You will be asked to submit a portfolio of eight 16" x 12" photographs.
- These images must be exclusive. This means none of the images can have been previously published, shared on any social media or seen by the media or other hairdressers prior to Tuesday 26th September 2023.

**Please include all of the following:**

## 1. EIGHT IMAGES

- Each photograph must be 16" x 12" (i.e. portrait dimensions). The total size should include any borders. Photographs should be supplied on photographic paper, or other thick paper to prevent damage when in transit. We would suggest a paper weight of 300gsm.
- Digital and print versions of your images are required. Please upload high resolution images directly to Evessio (our online platform) as you complete your entry. [bha.evessiocloud.com](http://bha.evessiocloud.com).

## 2. BEFORE IMAGES

- You must include a 'before' picture of each model, if applicable for your category. This should be taken on the day of the shoot, prior to any hair work, make-up or styling. Failure to provide these may result in disqualification. Each photograph should be no larger than 10" x 8".
- These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

## 3. PRE-PRODUCTION

- You must include an 'after' picture of each model, before any post-production or retouching. Failure to provide these may result in disqualification and the organisers and judges reserve the right to question any photographs which appear to have been edited. Each photograph should be no larger than 10" x 8".
- These images are only required in their digital versions. Please upload these to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).

## 4. VIDEOS

- You must take two, 360 degree videos of each model: one 'before' prior to any hair work, make-up or styling, and one 'after', before any post-production or retouching. This can be shot on your phone.
- Please upload these videos to Evessio (our online platform) as you complete your entry [bha.evessiocloud.com](http://bha.evessiocloud.com).
- Please provide a crib sheet, outlining the order in which you would like your pictures displayed. Please note, if this is not provided the organisers will display them at their discretion.



- Images will be displayed 1-8 as below, with the first picture being at the top and the fifth being directly below it on the second row. Please print this and enclose it with your entry.

- The organisers reserve the right to question any photographs which appear to be computer enhanced.
- All work submitted for the British Hairdressing Awards must be solely the work of the entrant.
- Your images must not be published prior to 31st January 2023. The HJ editorial team will advise which issue the images will be exclusively published in once the winners have been announced.
- Hairdressers Journal International retains exclusivity of the photographs submitted for the British category only until 31st January 2023.
- British nominees and models must be at the JW Marriott Grosvenor House, Park Lane, London W1, from 9am on Monday, 27th November 2023.

# PHOTOGRAPHERS' NOTES

- Entries must be supplied with a 'before' shot of each model taken on the day of the shoot, prior to any hair work, make-up or styling (with the exception of Avant Garde).
- 'Before' shots must be submitted online, with the exception of Schwarzkopf Professional Colour Technician of the Year where they must be submitted online and sent in print at 10" x 8".
- Entries must be supplied with an 'after' shot of each model, before any post-production/retouching. They must be submitted online with the exception of Schwarzkopf Professional Colour Technician of the Year where they must be submitted online and submitted in print no larger than 10" x 8" (portrait).
- Finished images must be 10" x 8" (portrait) with the exception of British Hairdresser of the Year. This includes any borders, and we advise the final images are printed on a minimum paper weight of 300gsm.
- Remember, it is the hair work that is being judged in the photographs.
- No more than two faces may appear in any one photograph.
- No more than four pictures can be used in two different categories. Exceptions below:
  1. If entering Avant Garde or Newcomer, your pictures can't be entered into any other category.
  2. If entering Schwarzkopf Professional British Colour Technician of the Year the same eight images can be entered into a region.



# ENTRY CHECKLIST

## CHECKLIST FOR SUBMITTING YOUR ENTRY

- Read the rules and make sure you are eligible to enter your category
- Check that your four prints measure 10"x8" portrait including borders
- Check that your final images are printed on a minimum paper weight of 300gsm
- Provide a crib sheet with your pictures in the order you would like them displayed. Please note, if this is not provided the organisers will display them at their discretion. For the first round this is displayed 1-4 vertically, with the first picture being at the top and the fourth at the bottom. Please print this and enclose it with your entry
- Label the back of each final photograph with your name, salon name and category.
- Upload your before and pre-production images when completing your online entry through [evecloud.com](https://www.evecloud.com)
- Complete the standard questionnaire required for the Artistic Team Category
- Complete the standard questionnaire – for each shot – in the Schwarzkopf Professional British Colour Technician of the Year category. Clearly label the before and after shots that are to be displayed at the judging
- Complete and sign the entry form below and pack this in with your printed images
- Ensure your photographer has completed and signed the declaration section
- Have your entry form authorised by your salon owner/ manager if required
- Newcomer of the Year category only - ensure your employer has signed the declaration and enclosed a copy of your passport or driving licence
- Make sure to take a video of your shoot. This needs to be a 360 degree video of each model before any work and on completion of the final look. This can be done on a mobile phone
- Ensure that the entry will meet the deadline of 5pm, Friday 30 June 2023

## HANDY TIPS

- Protect each individual photo when packaging your entry. **Do not** use paperclips, as these can damage your photographs.
- Please provide a crib sheet with your pictures in the order you would like them displayed. Please note, if this is not provided the organisers will display them at their discretion. For the first round this is displayed 1-4 with the first picture being at the top and the fourth at the bottom (as shown below). Please print this and enclose it with your entry.

- Ensure your photographer reads and signs the declaration form for you to return with your entry.
- We recommend using a hard-backed envelope or box to send your entry.
